As head of public policy for the Electronic Cigarette Industry Trade Association, Beckett was the primary advocate for the European vapor sector during the passage of the Tobacco Products Directive, which lays down the first set of rules for the category in Europe. Peter was instrumental in the foundation of the EU standards committee CEN TC 437 on vapor products.
