VAPOR TECHNOLOGY ASSOCIATION EXPANDS EFFORTS TO COMBAT ANTI-VAPOR LEGISLATION IN THE STATES

WASHINGTON, DC – Today, the Vapor Technology Association (VTA) announced it would expand efforts in the states as part of its ongoing campaign to combat legislation that would devastate small vapor businesses.
